NSAA media credentials are not for the use of children, sponsors, friends, family, spouses, parents or other individuals not representing a legitimate media outlet. Members of the media not abiding by these guidelines will have credentials reviewed for future events.

**Parking:** There is no charge for parking. At the Omaha site, parking is available on tier one directly south of the clubhouse. Overflow parking is available at the second and third tiers. At the Lincoln site, please view parking map below.

**Admission:** Admission is free to media and general public at both sites, however please have credentials visible.

**NSAA Headquarters** - Lincoln-Woods Tennis Center Clubhouse; Omaha-Clubhouse. A championship program along with any other additional contest information will be available to media members at these locations. Media Vests will not be utilized at this championship.

**Conduct/Etiquette:** As members of the media, you are representing your media organization. Team attire (i.e. booster buttons, school team shirts, etc.) will not be permitted by members of the media. Cheering directed toward a specific school or participant will not be allowed. Our goal is to maintain equity in the competitive environment.

\*Also, please have cell phones on silent when a match is in play.

**Photographs:** Photographers are not allowed to shoot photos on the court without permission or any area deemed inappropriate by onsite staff. Your cooperation is appreciated with this matter.

**Interviews:** Interviews are at the discretion of the coaches before/after matches. Interviews will not be conducted on the courts.

**Scores and Updates:** Contest updates will be posted on the NSAA website ([www.nsaahome.org](http://www.nsaahome.org)). Intermittent updates will also be available via the NSAA Events Twitter account ([@nsaaevents](https://twitter.com/nsaaevents)).

**Broadcasting:** Broadcast request forms must be submitted a **minimum of three days** to the State Championship. (See attached form) Any live coverage of NSAA State Championships will be subject to Broadcast Rights fees, [as detailed in the NSAA Media Manual](#). Phone and data lines are not available at the Girls Tennis Championships.

- ◆ Coaches and players **ONLY** park team vehicles in the Redeemer Lutheran Church lot located on the east side of 33<sup>rd</sup> Street (Red arrow and X)
- ◆ Parents and spectators please park in the main lot on the west side of 33<sup>rd</sup> St. (Blue arrows and X)
- ◆ Overflow parking is available on J St south of the baseball diamond. In addition there is overflow parking located west of the park accessible via 30<sup>th</sup> St on the west side of the baseball field and along Memorial Drive and N St throughout the park.
- ◆ Please **DO NOT PARK ON GRASS** areas or block driveways in the neighborhoods. All lots are actually closer walking distance to the tennis facility than parking in the neighborhoods. Please share this with your parents.
