

2008-2009 ACTIVITIES REGISTRATION INSTRUCTIONS

A \$45.00 registration fee is required for each activity in which your school participates. Submit in one payment the total registration for all the activities in which your school will participate during the 2008-2009 school year. The registration fees for Week 0 Football Schools are due August 8, 2008. Registration due date for all other schools is August 15, 2008.

Print a copy of your Registration Form for your files.

Each school had to declare by June 1, 2008, its participation in fall activities. Registration fees for those sports are to be included with your registration in all other activities.

If your school was undecided about fall activities on June 1, a final decision must be made prior to the opening date of practice for fall sports, which is August 11, 2008 for Week 0 Football schools; August 18, 2008, for all other schools. The NSAA office must be notified by that date.

The last date for registration in winter sports and non-athletic activities is September 1, 2008.

The last date for registration in spring sports is January 1, 2009.

Registration should be made early in all activities so district assignments can be completed and included in the NSAA Activity Manuals mailed to all schools registered in an activity.

Failure to pay the fee by the proper date may result in your school not being assigned to a district or state meet and not being sent the materials needed for the activity.

ENTRY FORMS

All entry forms are now done on line at the NSAA web site. Follow instructions according to what each entry form requires. If an entry fee is specified on the entry form, this will be used to help the district director pay for the conduct of the meet and, therefore, should be sent to the director.

The entry forms are due on the dates shown on the following page. These dates also appear on the NSAA Activities Calendar and will be announced in the Activities Bulletin. The entry form shall be done on line no later than the date due.

CO-OP APPLICATION/RENEWAL DEADLINES

Fall Activities – June 1
Winter Activities – September 1
Spring Activities – January 1

Complete and mail to the NSAA, Box 85448, Lincoln, Nebraska 68501-5448. Put an "X" to the left and \$45.00 to the right of each activity in which your school will participate. Be sure to sign the form.

Caution: Do not risk catastrophic insurance coverage lapse by failing to register on time!!

Submit this form with \$45.00 for each activity, in which your school will participate to the NSAA, P.O. Box 85448, Lincoln, NE 68501-5448, to be received no later than **August 15, 2008;**
August 8, 2008 for Week 0 Football Schools.

If a cooperative sponsorship agreement exists, write in the name of the other school(s) for each activity affected. **ALL SCHOOLS IN A CO-OP MUST PAY REGISTRATION FEES.**

****Schools registering for either boys or girls or both boys and girls Cross Country will also need to pay the Chip-Timing fee. This provides chips which will be used in the state Cross Country Championship. IN A CO-OP only the host school needs to pay the Chip-Timing fee.**

Registration should be made early in all activities, so that all registrations can be in the computer files used to complete district assignments and mail materials to the schools.

Only if a final decision has not been made regarding participation in an activity, indicate if there is a possibility of participation. In this case, the last date for registration in winter sports and for non-athletic activities is September 1. The last date for registration in spring sports is January 1, 2009.

****Schools registering for Wrestling will also need to pay the weight-management fee. This provides membership in the National Wrestling Coaches' Association, access to the weight-management software, passcodes to the software, and test strips. IN A CO-OP only the coach's home school needs to pay the weight management fee.**

Failure to pay the fee by the proper date may result in your school not being assigned to a district or state meet and not being sent the materials needed for the activity.
