## Affiliate Officials

Officials **living in** and **registering in** Kansas, Iowa, Missouri, South Dakota, Wyoming and Colorado may register in Nebraska by paying a \$10.00 per sport registration fee to the NSAA office in Lincoln.

### This reciprocity agreement applies to these states in the following sports:

Officials residing in these states who wish to officiate in other states in the agreement must first register with their own state association. Then they must apply for membership at a reduced fee in the other states. Nebraska refers to this as affiliate membership. Nebraska charges \$10.00 per sport for affiliate membership

If an official's home state association does not register officials in a particular sport (Wyoming does not register Softball officials, for example), then an official must register in Nebraska, just as Nebraska residents must.
