Rain out dates include Monday, May () and Tuesday, May () Proposal Change: The district tournaments will be single elimination with the winner qualifying for the state championship. All Class A schools in baseball are to be placed into six districts. The districts shall be determined using a serpentine method (not modified), based upon the NSAA wildcard point system within one week prior to the first district. Games through Tuesday of Week 44 will be counted for Class A district assignments and seeding. District games will be played on Thursday, Friday, and Saturday. (Week 44) Class A districts with a play-in game(s), the higher seeded team will be offered a contract to host that opening round game that will be played on Thursday. The top 12 teams will have the opportunity to host Semi-Final games. Those games will be played on Friday. (Week 44) The district championship will be hosted by the highest remaining seed. Those games will be played on Saturday. (Week 44). The top-seeded team in each district would be responsible for establishing district schedules and times. If the higher seed is unable to host the district tournament, the subsequent seed shall be offered a contract until a location is secured. Two additional

Summary: Class A basketball schedules will be based on a point system. Each team can accrue 22 points.

Single games are worth one point and tournaments are worth 2 points. Schools may participate in eighteen games and two tournaments in addition to the state sponsored series of tournaments. Schools may also play 20 games plus 1 tournament, or 22 individual games and no tournaments, or 16 games and 3 tournaments, in addition to the state sponsored series of tournaments. Rational:

Summary:

Soccer: 4 team districts play on Monday and Wednesday. Only games played on Saturday are play in games. Class A schools will be divided into seven districts. The teams with the highest wildcard point averages will have the opportunity to host districts. Class A districts will be Saturday (Week 43), Wednesday (Week 44) or Saturday (Week 43), Thursday (Week 44). All seven districts will be determined using a serpentine method (not modified), based upon the NSAA wild card point system after the games WEDNESDAY of Week 43. The winning boys team and the winning girls team in each district will qualify for the State Championship. One additional boys team and one additional girls team will also qualify for the State Championship on the basis of the wild-card team selection procedure. The top 14 teams will have the opportunity to host the first night of district competition. The district championship would be hosted by the highest remaining seed. District dates and times would be established before district competition starts. The top-seeded team in each district would be responsible for establishing district schedules. In a 5 team district, the play-in games will be played on Saturday (week). In a 4 team district, the district games will begin on Monday or Tuesday depending

on the date established by the top seeded team.

Rationale: Rational: 4 team districts will mirror a 5 team district once play-in games are finished.

Summary: 1. Outside Participation Track 3.2.3 Organized Practice Track and Field: An organized practice shall

mean more than 12 students under the direct supervision of a sponsor. If more than one group is practicing at the same time, it shall be called an organized practice. Unattached Participation The following guidelines should be followed in allowing out-of-season participation by students in meets or events which are not sanctioned or sponsored by the Nebraska School Activities Association and its member schools. a. Contestants shall not use any school uniform or be identified with the school. b. Contestants shall not use school equipment. c. The school shall provide no resources for the participants, or release coaches on school time to transport participants to or from the event, or to coach out of season athletic events. d. Coaches can attend unattended meets if there are no more than

12 students participating.

MANDATORY INPUT FOR VARSITY SCHEDULES (CLASS A ONLY) (CLASS A and B ONLY)

Article

Section

- 1. All Class A and B Varsity golf teams will be required to enter their complete regular season schedule by the respective deadline: a. Boys Class A and B Varsity Golf Schedules: Due: Thursday of Week 6 (August 8, 2024) b. Boys Class A Varsity Golf Schedules Due: Tuesday of Week 36 (March 12, 2025)
- 2. Once the golf season has begun, schools CANNOT add contests to their regular season schedules.
- 3. All Varsity scheduled contests shall be played with a Varsity team. Postponed contests shall be rescheduled by all participating schools if possible.
- 4. If your varsity team does not compete in an event on your schedule due to reasons other than weather postponements or cancelation, the respective school will be required to provide reasoning for non-participation.
- 5. Contest results for ALL contests on your varsity schedule are to be entered through the NSAA website in a timely fashion. Only events played on courses with official Nebraska Golf Association course ratings will be considered in the differential program.

Changes starting on Page 15 & 16 of Golf Manual:

*NOTE: #1 through #6 below are taken directly from Class A Differential with appropriate changes in bold underlined.

BOYS GOLF DISTRICTS

The Girls District Golf Tournament will be held October 7-8, 2024. The Boys District Golf Tournaments will be held May 19-20, 2025. The District hosts, sites and C and D school assignments will be posted to the NSAA website once all have accepted the hosting contract. Class A and B District Tournament assignments will be released on May 1, 2024.

Class A and B:

- 1. Class A schools are the schools with a combined enrollment of 850 and above playing boys golf and are assigned to four districts.
- 1a. Class B schools are those remaining schools that are in the top 80 but have an enrollment of less than 850 playing girls golf.
- 2. All Class A and B schools competing in a minimum of four VARSITY 18-hole stroke-play competitions will be assigned to four Districts using a serpentine method based on seeding determined by regular season team average differentials. Team average differentials are team score (four lowest players combined scores) minus (course rating from tees used x four players) = differential). The school with the lowest average differential is placed in District 1, the next lowest in District 2, the next lowest in District 3, the next lowest in District 4, the next lowest in District 4, the next lowest in District 3, etc., until all 32 schools are assigned. Assignments will be released two Tuesdays before the district tournaments.
- 3. Class A and B schools hosting regular season meets shall *report to the NSAA office the following results within 48 hours of the competition: a. the name of the golf course played, b. the names of each team including individual team members with individual and team scores, c. the course rating (for holes on the correct side) played from the tee box used for the competition. * Reports are submitted on-line from the AD's or golf coaches personal page at www.nsaahome.org. Note: Some teams that play junior varsity (JV) teams in varsity events will lower their placement as far as district ranking if those teams are listed as varsity teams. To avoid this, coaches should list these teams as JV teams when entering a varsity tournament. Only varsity team scores should be reported to the NSAA office for seasonal differential team tracking.
- 4. All season meets hosted on or prior to the Friday of Week 43 (April 26, 2024), are to be reported to the NSAA office by the meet's host director, or by the participating team's coach or AD if the varsity meet is out of state or not hosted by a Class A school.
- 5. Any schools not competing in at least four VARSITY 18-hole stroke-play competitions will be placed at the bottom of the seeding list in the order of their AVERAGE DIFFERENTIALS, lowest above highest on the list and placed in the sequential district.
- 6. District tournament host schools and specific golf courses will be selected before the season begins in order to secure hosts and golf courses for the events. After postseason seeding the host schools will be assigned to one of the four districts so there is one host-school per district. The NSAA Director of Golf will make the simplest one-team trades between districts so that host teams with the closest average differentials to a team in another district are switched. Schools are not allowed to host consecutive years unless necessary.

QUALIFYING FOR NSAA CHAMPIONSHIP (CLASS A and B ONLY)

1. The first three teams and the first ten individual places plus ties in each district will qualify for the NSAA Championship, using medal play. After districts are completed the NSAA will take as many individuals as needed so that there is a total of 15 individuals competing at the state golf tournament. Individuals will be selected according to individual differential for the season including districts. To be eligible a player must compete in at least five 18-hole competitions for the year and districts. (NSAA

will keep track on all Class A and B player's individual differential for the season.)

- 2. Playoffs will be used in case of ties for the NSAA Championship TEAM qualifying spots.
- 3. Schools that do not finish as one of the top three teams in the District cannot qualify for team honors at the NSAA Championship, even though that school may have qualified at least four individual golfers through individual placement at Districts.
- 4. A school which qualifies for the NSAA Championship may play any five eligible players at the championship. They do not have to be the same people who played at the district tournament. Any roster changes to the State Championship team should be communicated to the NSAA office to reflect such changes and ensure scorecards, scoreboards and tee times will be accurate. Any substituted player will be assigned the same tee time of the player being replaced.
- 5. An additional charge of \$25 be added to a Class A school's registration fee for boys golf and for girls golf for one year to cover programming costs that exceed \$500
- To make golf's regular season meaningful and to assure that we are getting the top teams/players to the Class B State Golf tournament each Spring.
 - 1. Golf is the only sport in which the regular season has absolutely no bearing on the opportunity to qualify for state competition (seeding, wildcard, etc.). Tracking team differentials and seeding districts accordingly makes the regular season matter rather than being an exhibition.
 - 2. The system has been established and is effectively working in Class A.

Cons: There could be travel for some teams after district seedings are assigned. Travel will be similar to what happens during state football and district volleyball and basketball.

Summary: This proposal looks to change the current Class B sub-district assignments wording to:

Class B sub-district assignments are created using the number of total Class B Teams and based solely on geographic location starting West and moving East. The number of sub-districts and number of teams in each sub-district will be assigned as follows:

#of total Class B teams; Sub-District Assignments

Greater than forty (40); Ten (10) sub-districts will be four teams with sub-districts of five teams being created for the extra teams over forty (40). The five team sub-districts will be the teams that are furthest East.

Equal to forty (40); Ten (10) sub-districts will be four (4) teams

Less than forty (40); The number of sub districts will be the result of dividing the total number of teams in class B by four (4) rounded down to the nearest whole number. Sub-districts will be four (4) teams with sub-districts of five (5) teams being created for the extra teams over the result of four (4) times the number of sub-districts. The five (5) team sub-districts will be the teams that are furthest

East

Rationale: This proposal would simplify the current verbiage pertaining to the class B sub-district assignments as

well as specify the number of sub-district assignments when the total number of Class B Teams is less than 40. The current verbiage only addresses sub-district assignments with 40 or greater teams. In situations where less than forty (40) teams have been classified in Class B, like the 2022 softball

season and the 2023 softball season, the far West sub-district has only included three (3) teams. This creates a situation where the three (3) team sub-district has the possibility of having a team only play one (1) game to qualify for districts whereas all others would have to play two (2) games. In order to create sub-districts that are as competitively equal for all regions as possible, this proposal would ensure all sub-districts would have to play a minimum of two (2) games by following a similar pattern to how all sub-districts are currently created with more than 40 teams.

Pros: Would eliminate the current scenario in which a sub-district would only have three (3) teams and have

the possibility of a team only playing one (1) game. All teams would have to play a minimum of two

(2) games.

Cons: Due to the possibility of varying number of sub-districts in the less than 40 team scenario, it would

also change the number of wild card teams in districts.
